OFFICIAL RULES AND REGULATIONS

Standard Friday Rockin' Bingo

1. AGREEMENT TO BE BOUND BY RULES:

By participating in this Friday Rockin' Bingo (the "Promotion") you are signifying your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules").

2. PROMOTION SPONSOR:

This Promotion is sponsored by Superior Shores Gaming Association (the "promotion Sponsor(s)"). The Promotion is in no way sponsored, endorsed or administered by, or associated with Ontario Lottery and Gaming Corporation ("OLG"). You understand that you are providing your information to the Site (as defined below in Rule 4) and not to OLG. OLG is completely released of all liability by each participant in the Promotion. Any questions, comments, complaints or concerns regarding the Promotion must be directed to the Site (as defined below in Rule 4) and not to OLG.

3. PROMOTION PERIOD:

Rockin' Bingo is played each Friday beginning on Friday, January 6, 2019 at 10:00 pm to 12:30 am and the last game is played Friday, December 27th 2019 at 10:00 pm to 12:30 am.

4. SITE:

Rockin' Bingo takes place at Superior Shores Gaming Association, 435 Memorial Ave., Thunder Bay, ON., P7B 3Y6 (the "Site").

5. ELIGIBILITY:

The Promotion is open to residents of Ontario (Canada) who are eighteen (18) years of age or older at the time of entry, except:

- employees (including full-time, part-time and student employees; persons who are directly on payroll; and employees who are on paid or unpaid leave), volunteers, directors or officers of: (i) the Site; (ii) OLG; (iii) the Alcohol and Gaming Commission of Ontario ("AGCO"); and (iv) any prize suppliers, advertising/promotion agencies and other entities or individuals involved in the development, production, administration or fulfillment of the Promotion;
- any Site staff or other individuals who are restricted pursuant to any OLG policy; and
- any and all charity volunteers who volunteer to conduct charity-related business on any day that the Promotion is scheduled to run, during the period they are volunteering only.

In the event that any participant (including, but not limited to, an eligible winner) does not meet the eligibility requirements stated herein, then such participant is subject to disqualification in the sole and absolute discretion of the Site.

6. HOW TO ENTER/WIN:

NO PURCHASE OR PLAY IS NECESSARY. To enter, you must visit the Site during the Rockin' Bingo to obtain "a ballot" (the "Entry Form"). Next, fully complete the Entry Form with all required information and deposit it into the Entry Box provided at the Site (the **Entry**). To be eligible, your Entry must be submitted and received in accordance with these Rules during the Rockin' Bingo.

The participant will get a ballot during Friday Twilight Rockin' Bingo. Ballots will be drawn and four (4) winning participants (2) the first half and (2) the second half will play King and Queen of Rockin' Bingo, and three (3) winning participants will spin the 'SPIN TO WIN' wheel (See attached addendum for SPIN TO WIN rules). Individual game rules will be announced on site. Ballots will be handed out at the POS station.

King and Queen participants will pick a number between 1 and 75. Each time the number they choose gets called, they will get a pick of envelopes with random cash or gift cards. Amounts of cash or gift cards valued at \$5 to \$20, during the Friday Twilight Rockin' Bingo.

No Purchase or Play is Necessary. Alternatively, you can obtain one (1) Entry in the draw by printing your first name, last name, telephone number and complete mailing address (including postal code) on a plain white piece of paper and mailing it (in an envelope with sufficient postage) or dropping it off in person to the Site at the address noted above in Rule 4 (the "Request"). Upon receipt of your Request in accordance with these Rules, you will receive obtain one (1) Entry in the Promotion. To be eligible, any Request you send must: (i) be received separately and in an envelope bearing sufficient postage (i.e. multiple Requests in the same envelope will be void); and (ii) be postmarked and received during the Promotion Period.

The Site, OLG, AGCO, all prize suppliers, advertising/promotion agencies and other entities or individuals involved in the development, production, administration or fulfillment of the Promotion, and each of their respective affiliates, officers, directors, employees, agents, representatives, successors and assigns (collectively, the "**Released Parties**") are not responsible for any Entry Forms, Requests, Entries or other materials that are late, lost, stolen, destroyed, delayed, misdirected, incomplete, invalid, illegible, unintelligible, damaged or otherwise impacted in any way whatsoever (all of which are void). Proof of submitting an Entry Form, Entry or Request will not be deemed as proof of receipt. All eligible Entries submitted and received in accordance with these Rules will be entered into the random prize draw(s).

7. ENTRY LIMIT:

There is a limit of "one (1) Entry(s)" (regardless of the method of entry). If it is discovered by the Site (using any evidence or other information made available to or otherwise discovered by the Site) that any person has attempted to: (i) obtain more than the maximum stated number of Entries as outlined in these Rules; and/or (ii) use multiple names, identities and/or any other unsanctioned means whatsoever to enter or otherwise participate in or to disrupt this Promotion; then he/she may be disqualified from the Promotion in the sole and absolute discretion of the Site. ANYONE DEEMED BY THE SITE TO BE IN VIOLATION OF THE LETTER AND/OR SPIRIT OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SITE AT ANY TIME.

8. VERIFICATION:

All Entries (regardless of the method of entry) are subject to verification at any time and for any reason. The Site reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Site – including, without limitation, government-issued identification): (i) for the purposes of verifying an individual's eligibility to participate in this Promotion; (ii) for the purposes of verifying the eligibility, validity and/or legitimacy of any Entry, Entry Form, Request or other information entered (or purportedly entered) for the purposes of this Promotion; and/or (iii) for any other reason the Site deems necessary, in its sole and absolute discretion, for the purposes of administering this Promotion in accordance with these Rules. Failure to provide such proof to the complete satisfaction of the Site within the timeline specified by the Site may result in disqualification in the sole and absolute discretion of the Site. The sole determinant of the time for the purposes of this Promotion will be the Site's Official Clock(s).

9. PRIZE(S):

King and Queen Prizes (each, a "Prize") will consist of \$5 to \$20 gift cards. See attached addendum

for Spin to Win prizing.

Each Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Site in its sole and absolute discretion). No substitutions except at Site's option. Site reserves the right, in its sole and absolute discretion, to substitute a Prize or a component thereof with a prize of equal or greater retail value, including, without limitation, but at Site's sole and absolute discretion, a cash award. All other costs, fees and expenses associated with a Prize that are not expressly indicated above will be the sole and absolute responsibility of the confirmed winner. Manufacturer's standard warranty, if any, applies to Prize. None of the Released Parties makes any representation or offers any warranty, express or implied, as to the quality or fitness of a Prize awarded in connection with the Promotion. To the fullest extent permitted by applicable law, each confirmed winner understands and acknowledges that he or she may not seek reimbursement or pursue any legal or equitable remedy from neither the Site nor any of the Released Parties should the Prize fail to be fit for its purpose or is in any way unsatisfactory. For greater certainty and the avoidance of any doubt, by accepting a Prize, the confirmed winner agrees to waive all recourse against the Released Parties if the Prize or a component thereof does not prove satisfactory, either in whole or in part.

10. ELIGIBLE WINNER SELECTION PROCESS (RANDOM DRAW):

At each Friday Twilight Rockin' Bingo session there will be four (4) random draws for the King and Queen games and three (3) random draws for the Spin To Win from the eligible Entries submitted and received in accordance with these Rules (See attached SPIN TO WIN addendum for rules). The odds of winning depend on the number of eligible Entries submitted and received in accordance with these Rules.

THERE IS NO REQUIREMENT TO BE IN ATTENDANCE AT THE SITE AT THE TIME OF THE RANDOM DRAW FOR THE SELECTION OF THE WINNERS.

11. ELIGIBLE WINNER NOTIFICATION PROCESS:

The Site or its designated representative will attempt to contact each eligible winner (using the information provided on the Entry Form/Request). If an eligible winner cannot be contacted within five (5) business days of the Draw Date, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Site, be disqualified (and, if disqualified, will forfeit all rights to the applicable Prize) and the Site reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries submitted and received in accordance with these Rules (in which case the foregoing provisions of this section shall apply to such newly **selected eligible winner**).

12. WINNER CONFIRMATION PROCESS:

BEFORE BEING DECLARED A CONFIRMED PRIZE winner, each eligible winner will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid (which may, in the sole and absolute discretion of the Site, be administered online, by email or other electronic means, by telephone, or in the Site's form of declaration and release); and (b) sign and return (within the time frame specified by the Site) the Site's declaration and release form, which (among other things): (i) confirms compliance with these Rules; (ii) acknowledges acceptance of the applicable Prize (as awarded); (iii) releases the Released Parties from any and all liability in connection with this Promotion, his/her participation therein and/or the awarding and use/misuse of the applicable Prize or any portion thereof; and (iv) agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Promotion and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Site in any manner or medium whatsoever, including print, broadcast or the internet. The Released Parties will not be liable for any failure or problems of any nature whatsoever, including, without limitation, the failure of any Entry Form, Request or other information to be received, captured or recorded for any reason whatsoever.

Entry Forms, Requests and other submitted materials are subject to disqualification where they: (i) have been tampered with; (ii) have been obtained, made, or replicated through fraudulent other means not expressly sanctioned by these Rules; (iii) are illegible, or have deteriorated; and/or (iv) contain typographical or other errors (all as determined by the Site in its sole and absolute discretion).

The Site reserves the right, in its sole and absolute discretion, to withdraw, amend or suspend this Promotion (or to amend these Rules) in any way, in the event of any cause beyond the reasonable control of the Site that interferes with the proper conduct of this Promotion as contemplated by these Rules, including, without limitation, any error, problem, tampering, unauthorized intervention, fraud or failure. Any attempt to undermine the legitimate right to seek remedies and damages to the fullest extent permitted by law.

The Site reserves the right, in its sole and absolute discretion, to cancel, amend or suspend this Promotion, or to amend these Rules, in any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever.

The Site reserves the right, in its sole and absolute discretion, to adjust any of the dates, timeframes and/or other Promotion mechanics stipulated in these Rules or elsewhere, to the extent necessary, for purposes of verifying compliance by any participant, Entry, Request or other materials with these Rules, or as a result of any problems or failures, or in light of any other circumstances which, in the opinion of the Site, in its sole and absolute discretion, affect the proper administration of the Promotion as contemplated in these Rules, or for any other reason.

Without limiting the generality of any other section in these Rules, the Site reserves the right, in its sole and absolute discretion, to administer an alternative test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

By entering this Promotion, each entrant expressly consents to the Site, its agents and/or representatives, storing, sharing and using the personal information submitted only for the purpose of administering the Promotion and in accordance with Site's privacy policy. This section does not limit any other consent(s) that an individual may provide the Site or others in relation to the collection, use and/or disclosure of their personal information.

In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Promotion-related materials, the terms and conditions of these Rules shall prevail, govern and control to the fullest extent permitted by law.

These Rules are governed by the domestic laws in force in Ontario and the federal laws of

Canada applicable therein. You agree to submit to the exclusive jurisdiction of the courts of the Province of Ontario and agree that those courts are a convenient forum in which to resolve

ADDENDUM

SPIN TO WIN

Once the eligible draw winner has been selected, he/she will then be presented with the “**SPIN TO WIN**” **Wheel**. The eligible draw winner will then spin the wheel to reveal the prize they are eligible to win (subject to compliance with these Rules and Regulations). The number of Spin Wheel prizes (and the approximate retail value of each prize) available to be won is listed below. Prizes are available while quantities last:

Participants must come up with a winning spin in order to be declared a winner. Winner will receive a prize corresponding to the combination received - as stated below.

The wheel must spin one (1) full rotation. If the wheel does not make a full rotation, then that “spin” does not qualify and you must spin the wheel again. This process will be repeated up to five (5) times or until the wheel spins one (1) full rotation, whichever comes first. If the eligible winner has not completed a spin with one (1) full rotation within five (5) attempts, then he/she may be disqualified in the discretion of the Site.
